The BoS will continue to accept the Notice on the 1<sup>st</sup> of every month. The Tax Collector SHALL not issue nor renew a motor vehicle road and bridge privilege license for any motor vehicle owned by a person who is delinquent in the payment of their solid waste fees assed and acknowledged by this Board. Further, the Delinquency Notice shall be kempt by the Chancery Clerk to permit filing of any liens created by the statute.

This Notice is provided to the Tax Collectors Office by Three Rivers PDD as the administrative agent for Kemper County BoS.
